LAW AND ORDER (MAINTENANCE) ACT [CHAPTER 65]

Publication of Order in Terms of Section 12 of the Act

IT is hereby notified, in terms of subsection (6) of section 12 of the Law and Order (Maintenance) Act [Chapter 65], that the Minister of Home Affairs has made the following order:

"ORDER IN TERMS OF SECTION 12 OF THE LAW AND ORDER (MAINTENANCE) ACT [CHAPTER 65]

I, Richard Chemist Hove, Minister of Home Affairs, in terms of section 12 of the Law and Order (Maintenance) Act [Chapter 65], hereby prohibit—

- (a) the hiring of vehicles by any organization or person for the purpose of carrying persons to any public gathering, as defined in section 12 of the Act, of a political nature, or at which the discussions and matters dealt with are of a political nature, except by the authority of the Minister;
- (b) the admission to such public gathering of persons who have hired or assisted in the hiring of vehicles; or have been carried to such public gatherings in breach of clause (a) hereof.
