POLITICAL PARTIES (FINANCE) ACT, 1992

Disbursement of Money to Registered Political Parties

IT is hereby notified, in terms of subsection (2) of section 3 of the Political Parties (Finance) Act, 1992, that in respect of the year ending on the 30th June, 1995:—

- (a) the total amount of moneys payable to registered political parties is thirty-two million dollars; and
- (b) thirty-two million dollars shall be paid to the Zimbabwe African National Union (Patriotic Front) (Z.A.N.U.) (P.F.), the only registered party eligible to receive money in terms of subsection (1) of section 3 of the Act.
