Notice of Acquisition of Agricultural Land under section 16B(2)(a)(iii) of the Constitution

Notice is hereby given, in terms of section 16(B)(2)(a)(iii) of the Constitution of Zimbabwe, that the Minister of Lands and Rural Resettlement hereby acquires for and on behalf of the State, the land identified and described in the Schedule for the purposes of settlement for agriculture.

Further take notice that ownership of the acquired land with full title therein vested in the State is with effect from the date of publication of this notice in the Government Gazette.
