LAND ACQUISITION ACT [CHAPTER 20:10]

Preliminary Notice to Compulsorily Acquire land

NOTICE is hereby given, in terms of section 5(1) of the Land Acquisition Act [Chapter 20:10], that the President intends to acquire compulsorily the land described in the Schedule for urban development.

A plan of the land is available for inspection at the following offices of the Ministry of Lands and Rural Resettlement between 8 a.m. and 4 p.m. from Monday to Friday other than on a public holiday on or before the 9th July, 2010.

(e) Ministry of Lands and Rural Resettlement, First Floor, Founder House, The Green, Marondera;
(f) Ministry of Lands and Rural Resettlement, 19, Hellet Street, Masvingo;
(g) Ministry of Lands and Rural Resettlement, Exchange Building, Main Street, Gweru;
(h) Ministry of Lands and Rural Resettlement, Office No. F20, First Floor, Mtshabezi Building, Gwanda;

Any owner or occupier or any person who has an interest and right in the said land, and who—

(b) wishes to claim compensation in terms of Part V for the acquisition of the land;
