Loan Agreement between the Republic of Zimbabwe and the Arabic Bank for Economic Development in Africa

### TERMS OF LOAN AGREEMENT

1. The loan amount is ten million United States dollars.
2. The loan interest shall be 2 *per centum* per annum.

3. The borrower shall pay the principal of the loan in fourty semi annual instalments after the grace period of five years to be calculated from the first day of the month following the first withdrawal from the loan account.
4. The loan facility shall be utilised for the procurement of the personal protective equipment and laboratory equipment for purposes of fighting the COVID-19 pandemic.
